CIRCULAR

The <u>Mukhyamantri Vigyan Pratibha Pariksha</u> for students studying in Class-IX is meant to identify and nurture the talent. The examination is conducted by Directorate of Education GNCT Delhi every year.

<u>Scheme details;</u> The qualified candidates whose merit is within 1000 (Category wise) will be eligible with one time scholarship of Rs.5000/- and a certificate.

<u>Date of Examination</u>: The Exam will be conducted at various centers in DOE schools of Delhi on 03/12/2023 (Sunday).

<u>Eligibility:</u> (i) The students presently studying in Class IX in Govt., Govt. Aided, Unaided recognized Pvt. Schools including the Kendriya Vidyalaya, Jawahar Navodaya Vidyalaya, School of NDMC, DCB, etc. in GNCT of Delhi.

(ii) Must have secured 60% marks in Class VIII in the session 2022-2023, 5% relaxation in marks for the students belonging to SC/ST and Divyang (Disabilities) category.

<u>Reservation</u>:- 15% of the students belonging to the SC Category, 7.5% for students belonging to the ST category and 27% for students belonging to OBC category (**Non-creamy layer**) as per Government of NCT Delhi Revenue Department, 10% for Economically Weaker Sections (EWSs) those who have not covered under the reservation scheme for SCs/STs/OBCs, 4%(with in category) for children with benchmark disabilities, of which, one percent each shall be reserved for persons with bench mark Disabilities under clauses (a), (b) and (c) and one per cent for persons with benchmark disabilities under clauses (d) and (e) namely:-

- (a) Blindness and low vision; (Visually impaired low vision)
- (b) Deaf and hard of hearing; (Hearing impaired)
- (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy; (LD)
- (d) Autism, intellectual disability, specific learning disability and mental illness; (AID)
- (e) Multiple disabilities from amongst persons under clauses (a) to (d) including deafblindness in the posts identified for each disabilities (MD)

- <u>Selection:</u> (i) Qualifying Marks: Qualifying Marks for candidates from SC/ST/PH category is 32% in both test(Mat & Sat) and for others General/OBC & EWS categories it is 40% in both test(Mat & Sat).
- (ii) The selected students as per merit (Category wise) and as per quota will be recommended for scholarship.
- <u>How to Apply:</u> (i) The HOSs can register the details students on the Directorate of Education website <u>www.edudel.nic.in</u> with their own school login ID and Password► School Plant► Scholarship► School information entry form► Application form.
- (ii) The schools can register their eligible enrolled students from 07/08/2023 to 09/09/2023.
- (iii) The Directorate of Education, Science Branch will generate Roll Numbers of the candidates and allot the Centers of Examination by 20 November 2023.
- (iv) The HOS can take print out of the admit card, attest and issue 2 (Two) copy to the students on or before 02 December 2023.

## Note:- <u>Heads of Schools are requested to ensure the following (while submitting the</u> application form);-

- 1. The candidates who claim to be under EWS (Economic Weaker Section) category, will have to provide only EWS (Economic Weaker Section) certificate not Income certificate (Sample attached) and which will be valid for the year 2023-24.
- 2. The OBC candidates will provide the OBC (Latest Non-Creamy Layer) certificate only,
- 3. If EWS (Economic Weaker Section) certificate /OBC (Latest Non-Creamy Layer) certificate is not provided by the candidate at the time of application/registration, he/she will be treated as a general candidate.

4. Provided the account/bank details of the candidate/student only.
